



CREATING JOBS FOR IPSWICH

The Queensland Budget will directly support job creation in the Ipswich region with significant expenditure including:

Infrastructure

\$802M

for productivity-enhancing infrastructure and capital works, estimated to support around **2,600 jobs** in this region in 2020-21.

Health

\$691M

for the West Moreton Hospital and Health Services.

Education

\$102.9M

to maintain, improve and upgrade schools in lpswich.

Solar Halls Powering Growing Communities -Esk Civic Centre

> \$6,828 in 2020-21 out of a \$20,652 total spend to install a 30kW rooftop solar system to provide renewable energy to the Civic Centre.

Southern Queensland Correctional Precinct

> \$654 million to expand Southern Queensland Correctional Precinct with a new 1,000-bed correctional centre focusing on health and rehabilitation to reduce reoffending.

Glamorgan Vale State School

> \$750,000 in 2020-21 to replace the existing amenities block.

Fairways Park

\$1.6 million in 2020-21 out of a \$1.7 million total spend to install multi-element playgrounds that cater for all ages and abilities including the addition of a dog off-leash park and car park.

Hatton Vale State School

\$1.4 million in 2020-21 for additional classrooms and to replace the school's septic system.

Oxley Priority Development Area

\$15.5 million in 2020-21 out of a \$30.8 million total spend for the development of the former Oxley Secondary College site to facilitate economic development and development for community purposes in the area.

Suttons Park Skate Bowl

\$1.1 million in 2020-21 out of a \$1.2 million total spend to upgrade the existing skate park at Suttons Park, Brassall. Works will include a new skating facility, shade and seating, and landscaping.


East Ipswich train station

\$17 million in 2020-21 out of a \$37.7 million total spend to upgrade East Ipswich train station to provide improved access and facilities.



Murri Court

\$916,000 in 2020-21 out of a \$4.1 million total spend (for the period 2018-19 to 2022-23 and \$1 million ongoing) to maintain a Murri Court at Ipswich.





Augustine Heights (Springfield) fire station

There will be a new fire station with full-time firefighters in Augustine Heights (Springfield).



26 Springfield AFL

\$3 million in 2020-21 to the Brisbane Lions, taking the total State contribution to \$18 million, to deliver an AFL stadium at The Reserve in Springfield.



Springfield Central train station park 'n' ride

\$17.6 million in 2020-21 out of a \$44.5 million total spend to upgrade the Springfield Central train station park 'n' ride facility to provide an additional 650 car spaces.



Southern Downs Child and Family Centre

\$2.1 million in 2020-21 to establish a centre to better manage service demands. population growth and make the most effective use of resources in Child Safety.



Ripley Valley Priority Development Area Infrastructure

\$28.6 million in 2020-21 out of a \$45 million total spend for catalyst infrastructure within the Ripley Valley Priority Development Area.



Springfield Central State High School

\$10.3 million in 2020-21 out of an \$11.5 million total spend for additional classrooms.



Springfield Central State School

\$4.2 million in 2020-21 out of a \$9.3 million total spend to construct a new building with additional classrooms.



Hardings Paddock Community Hut

\$576,000 in 2020-21 out of a \$640,000 total spend to construct a council operated community hut at Hardings Paddock.



Boonah Town Centre Revitalisation

\$293.920 in 2020-21 out of a \$1.5 million total spend to redevelop the Boonah CBD to generate a sense of place that is visually appealing and supports community and business engagement.



Lake Moogerah Caravan Park Facilities Upgrade **Project**

\$1.8 million in 2020-21 out of a \$2 million total spend to upgrade the facilities and grounds at the Lake Moogerah Caravan Park to encourage tourism and deliver positive economic benefits to the community.



Ipswich Hospital upgrade

Queensland Health has committed an additional \$22 million over three years for interim upgrades to meet the increasing healthcare needs of Ipswich's growing and diverse community while a master planning process is underway.

This investment will deliver upgrades to the emergency department, a dedicated obstetric theatre and an expansion to renal and nephrology services. These commitments are in addition to a \$146.3 million investment for the initial stage of an expansion of the Ipswich Hospital and development of a Health Precinct. The investment includes the delivery of a \$91 million 50-bed Acute Mental Health Unit and a \$25 million 26-bed ward at Ipswich Hospital.





Centenary Bridge upgrade

The Queensland Government has committed \$132 million towards the \$244 million upgrade of the Centenary Bridge, to be funded in partnership with the Australian Government (\$112 million contribution).

The Centenary Bridge carries more than 85,000 vehicles a day and current traffic modelling shows that by 2036 about 150,000 vehicles per day will cross the bridge.

The proposed upgrade includes a new, three-lane, northbound bridge and remediation of the existing bridge to create three southbound lanes, improving connectivity with Brisbane for Ipswich and Springfield commuters. The design also includes improved active transport facilities for pedestrians and bike riders.

When delivered, the project will improve safety, efficiency and travel times, better outcomes for the community, and provide better and safer facilities for active transport users.

Tax Relief Package

The Government provided significant tax relief to support Queensland businesses, landlords, tenants, pubs and clubs, including:

- Payroll tax refunds, waivers and deferrals for eligible businesses, targeted at small to medium businesses
- A payroll tax exemption for wages subsidised by the JobKeeper payment
- Land tax rebates, waivers and deferrals for eligible taxpayers.

An estimated 320 businesses in Ipswich will also benefit in 2020-21 from the higher payroll tax threshold.


STATEWIDE HIGHLIGHTS

This Budget is focused on creating jobs and getting our economy moving sooner. Initiatives include:

- Driving the largest infrastructure program in over a decade \$14.8 billion in 2020–21, directly supporting 46,000 jobs. Around 58% of the capital program and 28,700 of the jobs supported will be outside the Greater Brisbane area.
- Enhancing frontline services.
 The Budget will support funding for additional frontline health staff including 5,800 nurses, 1,500 doctors and 1,700 allied health professionals through to 2024.
- Backing small businesses
 to support jobs and
 communities. More than
 \$7 billion in COVID-19
 stimulus measures have been
 provided so far, including
 reducing business costs
 through payroll tax relief and
 other tax relief measures,
 and accelerating projects
 to unlock development and
 increase economic activity.
- Increasing investment in manufacturing including \$1 billion to make trains again in Queensland.

- Growing our regions and supporting key industries such as tourism, agriculture and mining. An additional \$200 million will be provided to the Works for Queensland program to support local governments outside South East Queensland.
- Providing more Queenslanders with access to the skills and training they need for rewarding careers. \$100 million has been provided over three years to upgrade TAFE campuses.
- Providing concessions and easing the cost of living, with an estimated \$6.3 billion in 2020–21 in targeted discounts, fee waivers, rebates, and subsidies.
- Protecting the environment.
 The Great Barrier Reef will benefit from an additional \$40 million worth of support. This includes \$10 million for a Reef Assist Program and \$6 million over four years for the GBR Island Arks project to deliver ecotourism in the region.
- Delivering lower debt than New South Wales and Victoria.
