The program also includes planning for the Gympie Arterial Road and a new road along the North South Urban Arterial corridor between Dohles Rocks Road and Anzac Avenue. # **Investing in Moreton Bay** health services

The Queensland Government is investing more than \$481 million to deliver new and upgraded health services for the fast-growing Moreton Bay region.

The government is investing \$352.9 million in the Caboolture Hospital Stage 1 redevelopment, which is supporting approximately 1,027 full time construction jobs over the life of the project. The project will support an additional 130 beds and refurbishment of critical clinical support services.

In addition to the redevelopment, the Queensland Government is investing \$46.6 million for delivery of a multi-storey carpark, which will provide an additional 1,080 carpark spaces, including electric vehicle charging bays and motorcycle parking.

At the Redcliffe Hospital site, the Queensland Government is investing \$56.3 million in projects, supporting 167 full-time construction jobs. Once delivered, the investment will provide improved facilities including a new MRI and the redesign of the paediatric emergency department.

Additionally, Caboolture and Bribie Island are two of the seven areas selected as part of the new \$265 million Satellite Hospitals Program. These satellite hospitals will enable our acute hospitals in South East Queensland to manage demand and free up capacity, while continuing to safely manage patients via alternative models of care.

# **Investing in Moreton Bay schools**

The Queensland Government is investing in schools across the Moreton Bay region to give all children a great start, engage young people in learning and build Queensland's growing communities.

School improvements in the Moreton Bay region include:

- Burpengary State Secondary College's recently completed new learning centre, providing students and teachers with 12 new learning spaces and four specialist learning classrooms
- Pumicestone State School's recently completed \$10 million multi-storey learning centre, providing students and teachers with 12 new learning spaces and a purpose-built music classroom. It also includes the extension to the Prep covered play area and an expansion of the carpark improving the traffic flow around the school.

These investments are helping to meet enrolment growth at these schools. Over the two years of construction, the projects have supported an average of 28 jobs.

# STATEWIDE HIGHLIGHTS

The Queensland Government's Economic Recovery Plan continues to support businesses, workers, families and communities across the state. Our success in managing the health challenges imposed by the COVID-19 pandemic means the state's \$360 billion economy has begun to recover sooner and is stronger than the rest of Australia.

2021-22 Budget highlights include:

- Record health investment of \$22.2 billion will continue to provide a world-class health system, which is also critical to effectively manage the ongoing risks of COVID-19.
- The new \$3.34 billion Oueensland Jobs Fund focuses on investment attraction and industry development to attract the investment needed to drive ongoing growth, and provide wider economic and employment benefits.
- The \$52.2 billion capital program over the forward estimates will help create many thousands of ongoing jobs, including an estimated **46,500** direct jobs in 2021-22.
- \$460 million toward targeted investments in flagship skills and training and employment programs Skilling Queenslanders for Work and a revitalised Back to Work program.

# Tax relief package

The government provided significant tax relief to support Queensland businesses, landlords, tenants, pubs and clubs, including:

- payroll tax refunds, waivers and deferrals for eligible businesses, targeted at small to medium businesses
- a payroll tax exemption for wages subsidised by the JobKeeper payment
- land tax rebates, waivers and deferrals for eligible taxpayers.

An estimated 1,010 employers in Sunshine Coast and Moreton Bay will also benefit in 2021-22 from the higher payroll tax threshold.


# \$2 billion Queensland Renewable **Energy and Hydrogen Jobs Fund**

The \$2 billion Queensland Renewable Energy and Hydrogen Jobs Fund will provide cheaper, cleaner energy to power more jobs and industries in Queensland, while helping to deliver on our 50 per cent renewable energy target by 2030.


The Fund will increase investment by government-owned corporations in commercial renewable energy and hydrogen projects, along with supporting infrastructure, including in partnership with the private sector.

Forming part of the new \$3.34 billion Queensland Jobs Fund, this investment will ensure Queensland capitalises on economic development opportunities and creates more jobs and industries through cheaper, cleaner energy.


#### 2021-22 revenue
