

Queensland State Budget 2011–12

Regional Budget Statement



Greater Brisbane

Over the 2011 summer, Queensland experienced State-wide devastation from natural disasters.

The floods and Cyclone Yasi saw 100 per cent of Queensland local government areas declared disaster affected and triggered the largest rebuilding and recovery operation ever undertaken in this state.

The 2011-12 Budget fosters that recovery, while also providing relief for families. My Government's decision to abolish the ambulance levy will provide immediate relief for families doing it tough.

There is also a new \$140 million Queensland Building Boost, to stimulate the housing sector and make it more attractive for people to purchase their first home.

We will also implement reforms to our education system by moving Year 7 into high



school, enabling our children to get full benefit from the new Australian Curriculum. This Budget invests a record amount in events funding - an \$85.8 million boost over five years - to help Queensland attract major events and drive up tourism numbers. This is a Budget built on strength of spirit that will restore long-term social and economic prosperity to the Greater Brisbane region and right across the State.

On track for recovery from the global financial crisis, Queensland's economy was instead faced with the worst floods in 100 years and Cyclone Yasi.

Building Queensland's recovery and helping families with the cost of living

Helping Queenslanders into new homes

- Massive stimulus package for building new homes
- \$10,000 grant for a new home contracted between 1 August 2011 and 31 January 2012
- Zero stamp duty for first home buyers under \$500,000
- First home owners can now receive up to \$17,000
- Kick-starting the housing market, generating jobs and construction

Rebuilding Queensland

 \$6.8 billion in State and federal disaster funding, including \$2.9 billion on roads, \$2.75 billion for local governments and \$656 million for small business, non-profit organisations and primary producers

Supporting jobs and investing in the future

- \$100 million over three years in new Smart State initiatives
- \$85.8 million over five years to attract new events to support tourism

- \$75 million to support investment in solar power energy generation
- \$60 million to the end of next year for ClimateSmart Home Services – reducing households bills and carbon emissions

- \$30 million to complete the \$146.7 million expansion of the Brisbane Convention and Exhibition Centre.
- \$241.7 million towards the \$1.402 billion Queensland Children's Hospital.
- \$66.3 million to complete the \$465.8 million Eastern Busway between the South East Busway and Main Avenue, Coorparoo.
- \$1 million to complete the new Carina Police Station.







• \$8.2 million to acquire and manage a new national park on North Stradbroke Island.

Disaster response funding

- \$137.3 million to local governments for recovery and reconstruction projects, in partnership with the Australian Goverment, including to rehabilitate riverside parks in Brisbane.
- ♣ \$26.5 million of \$170 million to restore the prime transport connections between Brisbane and southern Queensland by repairing sections of the Warrego Highway.
- ♣ \$72.5 million of \$145 million to be provided to fasttrack reconstruction of Brisbane Ferry Terminals and the Riverwalk, in partnership with the Australian Government.
- ❖ \$16 million to reconstruct the AJ Wyllie Bridge on Gympie Road, Petrie, to improve flood resilience to future weather events.



Cost of living support for Queenslanders

Supporting Queenslanders by improving access to and affordability of a range of services:

- **\$140 million** to reduce the cost of electricity bills by abolishing the Community Ambulance Cover levy.
- **\$165.9 million** for cost of living concessions, to improve affordability of council rates for pensioners and electricity for pensioners and seniors.
- \$17.5 million to provide cost of living concessions to pensioners for South East Queensland water costs. In 2011-12, the subsidy will increase by \$20, to \$120 per annum.
- **\$1.073 billion** to subsidise public transport costs for trains, buses and ferries across South East Queensland.
- \$37.6 million in travel assistance to help students with disabilities access school programs to meet their individual needs.
